Terms and Conditions

1. Introduction

Welcome to download-pal.com ("DownloadPal"). These Terms and Conditions ("Terms") govern your use of the DownloadPal website and services (collectively, the "Service"). By using the Service, you agree to these Terms. If you disagree with any part of the terms, you may not use our Service.

2. Use of the Service

- "DownloadPal" (or "we", "us", "our") refers to the company operating the Service.
- "User" (or "you", "your") refers to the individual or entity using the Service.
- "Content" refers to any files, links, or data that Users process through the Service.

3. Description of Service

DownloadPal provides a secure file sharing service that allows Users to create unique download links for their files. We do not store Users' files, but rather provide a secure method of sharing access to files stored elsewhere.

- Nature of Service: DownloadPal provides a secure file sharing service that enables Users to create unique, encrypted download links for their files. Our platform functions as a security and access management layer for digital file distribution.
- File Storage: DownloadPal does not store Users' files on its servers. Instead, we provide a secure method of managing and controlling access to files stored on Users' existing storage platforms, including but not limited to cloud storage services, private servers, or other hosting solutions.
- Functionality: The Service operates as follows: Users provide DownloadPal
 with the source link to their file. DownloadPal encrypts it and generates one or
 more unique download links associated with that source link. These
 generated links incorporate various security features, which may include
 expiration dates, download attempt limits, and download notifications. Users
 can then share these links with their intended recipients, who can access the
 file by clicking on the link.
- Security Measures: DownloadPal employs industry-standard encryption and security protocols to protect the source links and generated download links. However, the security of the original file storage location remains the responsibility of the User.
- Access Control: The Service allows Users to set and modify access parameters for each generated link, including but not limited to expiration dates and download limits. Users retain full control over these settings and may revoke access at any time.

- Analytics: DownloadPal provides Users with analytics and tracking information related to the usage of their generated links. The extent and detail of this information may vary based on the User's subscription level.
- Recipient Experience: Recipients of DownloadPal-generated links do not need to create an account with DownloadPal or install any software to access shared files. They simply use the provided link to download the file, subject to any restrictions set by the User.
- Integration: The Service is designed to work in conjunction with Users' existing file storage solutions, enhancing rather than replacing these systems.

4. User Accounts

4.1 Account Creation

To use certain features of the Service, you must create an account. You agree to provide accurate, current, and complete information during the registration process and to update such information to keep it accurate, current, and complete.

4.2 Account Responsibility

You are responsible for safeguarding the password and email address that you use to access the Service and for any activities or actions under your password. You agree not to disclose your password to any third party.

4.3 Account Termination

We reserve the right to terminate or suspend your account immediately, without prior notice or liability, for any reason whatsoever, including without limitation if you breach the Terms.

5. User Responsibilities and Conduct
